Dave Neubecker, Assistant Planner, Downtown Region, CRA:

Metro's 2007 Call for Projects initial funding recommendations include four proposed public improvement projects in the HCNC area:

- 1) Cesar Chavez Transit Corridor (110 Fwy to Alameda St.) pedestrian improvements: 'bus stop gardens' at three locations along Cesar Chavez westbound at Evans School, westbound between Spring & Broadway, and eastbound on the island at the SW corner of Spring & Cesar Chavez as well as street trees, landscaping, pedestrian lights, enhanced crosswalks, and wayfinding signage along the corridor. Proposed by CRA; \$2.35 million total cost, with Metro providing \$1.7 million.
- 2) Downtown LA Alternative Green Transit Modes Trial Program transportation demand management project: contractor-operated transportation service providing an alternative way to travel the 'last mile' from transit stations to major activity centers utilizing electric-motor-assisted 2-passenger bicycle-transit type vehicles and 3-passenger Neighborhood Electric Vehicles, with a weekday Union Station-City Hall route and various routes tested on evenings & weekends. Proposed by CRA; \$1.025 million total cost, with Metro providing \$0.8 million.
- 3) Solano Canyon-Zanja Madre-Chinatown-Broadway Bus Stop pedestrian improvements at 8 bus stops along North Broadway from Bernard St. to Solano Ave., with street furniture and landscaping. Proposed by Bureau of Street Services; \$1.1 million total cost, with Metro providing \$0.9 million.

4) El Pueblo Pedestrian Improvements Phases I thru IV: design & construction of enhanced facilities to improve & assist pedestrian movement in the El Pueblo District and other landmarks in Downtown L.A. Proposed by El Pueblo; \$12.8 million total cost, with Metro providing \$5.5 million.

Don Toy has requested Dave Neubecker to provide copies of materials, plans, drawings, etc. for Cesar Chavez Transit Corridor project, and Solano Canyon-Zanja Madre-Chinatown-Broadway Bus Stop Improvements proposed by CRA. Also, Don asked if the proposed CRA project signage could include languages other than English, i.e. Chinese, Spanish. In addition, there should be multi-lingual outreach conducted in the community regarding these proposed projects.

- 2) Public Comments for youths and seniors: 10 minutes skipped because of visitors.
- 3) Approval of Minutes March 13, 2007 Jose Luis Sedano Motion to approve minutes Gay Yuen and Tim Keating. Motion approved.
- 4) Spring Street Bridge Mike Fong: The engineer and consultant team will present an overview of the project, timeline, and design alternatives they are considering.
 Wallace Stokes and Ejike Mbaruguru Dept of Public Works. Presented a Point Presentation on the project, showing 4 alternatives with advantages and disadvantages. Funded by both State and Federal Funds. During construction will be some noise, but the bridge is away from areas of habitation. Some impact on park during construction. Will improve transportation and traffic. Bridge is eligible for listing on National listing and will maintain the historic character of bridge. It will have an historic sign. Open for public review up to winter of 2007. Budget \$20,000,000. Bridge needs to be upgraded seismically. Website: www.NorthSpringStreetBridgeProject.org. HCNC will publish link on our website.

Fabian Wagmister: his family owns the Charles Raphael Building that could be demolished. Unanimous recommendation to make building an historic monument. 2nd oldest industrial building in LA. Want to turn it into a Community Center.

El Pueblo: Howard Fink: way-finding /monument signage project working with the City and the local non-profit group. Amount will be about \$21,000. Howard Fink introduced presentation provided by
