3. Brian Kito: Happy New Year, we are starting off the meeting in a moment of silence for Mrs. Brown. We would like to give everyone an opportunity to say something about Mrs. Brown. Alejandra Flores: Alicia was the first person that I talked to about bringing LATA to Elysian Park. I knew that I needed her blessing. She was always working for LATA, and she brought me to this space. We are here because of her. It will be very difficult for us to find the right person to represent us.

Edmund Soohoo: I was a classmate of one of her sons who has passed (Gary). To her credit, she has always been an advocate and tenacious in advocating for her community. Whether or not I agreed with her.

Alan Kumamoto: It is hard to now what to say about her. Between the Cornfield and the Elysian Park and she was always there for the community and the city.

Lauren Bon: I am here to show my respect for Alicia. In 2005, I had a plan to plant corn on what is now the Los Angeles State Historic Park. I started knocking on doors. Mrs. Brown was the fifth door I knocked on. She proceeded to take me around the neighborhood to meet the neighbors and tell them that they had better support the effort. I am in the process of permitting for a water wheel on the Los Angeles River, and Alicia was part of that idea. There used to be 3 water wheels on the river. Mrs. Brown was disappointed in the design. Mrs. Browns showed me that it's important to show up for the community that you are engaged in. That is why I am here. Brian Kito: the last couple of years were hard, but her heart was there, always. She was still a trouper. She would call me later to ask about what she did not understand in a meeting.

3. Planning Presentation:

Conditional Use Permit: next to JANM- beer and wine for convenience store, no off-site consumption. Application and plans submitted.

Howard Nishimura: in the past, whenever there is offsite sales of liquor, we have had problems. Can we put in a stipulation to have guardsfor security in front of the store.

Judy: no malt liquor, no single cans, nothing less than \$7.00 per item. Willing to cap liquor sales at 12am. Working with LAPD to consider conditions.

Howard: Little Tokyo Community Council has not addressed the issue yet.

Judy: CD 14 is supportive.

Brian Kito: Little Tokyo Community Council is made up of small business and non-profits, they should hear this issue and decide. We can vote in support of this CUP request in the event that the community council approves. If you want to stay open until 1am, you might need security. I have to excuse myself on any vote since I own an establishment within 500 feet of the Family Mart. Will you be able to commit to a security guard now? Kenji Suzuki agrees with this.

Lydia: What is being sold there now?

Near Sci Arc—next to 1 Santa Fe. At the outset we wanted input from neighborhood. Have input from the BID and from LARABA. 3 buildings on 6.8 acres. Leasing office at 950 East 3rd. Retail and residential with pool and garden. 3 buildings. Concerns were accessibility for the neighborhood because it cuts the neighborhood off. We will add a private street open to the public. 900 underground parking spaces. Landscape to be unveiled.

This does not affect SciArc parking. Trying to incorporate and blend in with the neighborhood as much as possible. Variegated treatment of facades. (see renderings). Rental units, \$1400/\$2000 per unit.

Tim Keating: we used to have a policy not to approve a project unless 15% was affordable. Caucus recommends HCNC give support.

Yuval Bar Zem- the entitlements for this were given a long time ago. The Arts District is in an unusual situation—live work lofts were always available. Now there is a push for high volume residential units. This is a quality design, but we do not know about the interior and whether or not there is space for artists and the original intent and

entitlement of the neighborhood. It is a unique neighborhood that has a character that cannot be replicated, only protected. 1 Santa Fe is an enormous project. We have to be careful that the charm and the character of the neighborhood is not washed away.

Brian Kito: Little Tokyo goes through growing pains, too. I felt the same way when I saw the places being built.

Mark Rothenberg: I was there when the entitlements were issued. We wanted to allow for artist residences and for standard residential units. I was interviewed for this project. My office is across the street from this project. The appearance is interesting. 6.8 acres is a major key linkage point—it does not allow for pedestrian access and circulation, it's a fortress. We recommend more through traffic for pedestrians.

Grant: we have opened up for some pedestrian access.

Mark: There is a lot of high end use and a lot of gentrification. We (my firm) wanted to lift the building and open more open space. Our idea is that this should have had a park.

They do not need our input, but they are working with us.

Motion by Mark Rothenberg to support the project with the condition of continuing dialogue, 6-7 more renderings and fully delineated landscape, and opening up of pedestrian access. Brian Kito seconds. All in favor. Motion approved.
